I understand that if OXYGEN are unable to sell any of the goods they will have the right to dispose of the goods as they see fit.

I agree that OXYGEN will not be responsible for any loss or damage to any goods brought into the shop for sale.

I agree that OXYGEN <u>will not</u> write to me to confirm donations, if the total value of the money raised, after deduction of Commission and VAT (Net Sales Proceeds), from the sale of my goods in any tax year is equal to or less than £100 and the Net Sales Proceeds will be treated as a donation to OXYGEN			
I understand that OXYGEN <u>will</u> contact me, if the Net Sales Proceeds are in excess of £100 to give me			
the opportunity to donate the proceeds in excess of £100

I understand that OXYGEN will send me an end of tax year letter, even if monies raised are less than
